### DECLARATION OF CHOICE OF APPLICABLE LAW AND JURISDICTION

The undersigned,

1. I am legally entitled under the laws of my Current Country of Residence to choose a contract under foreign laws and therefore I exercise such choice and elect the laws of my Country of Nationality in respect of the Policy with Utmost Luxembourg S.A.
2. I am aware that the Policy may not comply with the laws and regulations of my Current Country of Residence.
3. I am aware that this choice of applicable law has no effect on my fiscal obligations in my Current Country of Residence.
4. I elect the exclusive jurisdiction of the courts of my Country of Nationality.
5. Utmost Luxembourg S.A. shall not be liable for any loss arising out of the Policyholder's choice of applicable law and jurisdiction in connection with the Policy inclusive of, but not exclusively, any negative tax consequence.

Utmost Luxembourg S.A. has not provided and will not provide any legal or tax advice to the Policyholder, including in connection with the treatment of the Policy in the Current Country of Residence.

6. I indemnify Utmost Luxembourg S.A. from all liability in relation to my choice of governing law and jurisdiction and will not undertake any legal court or out of court actions against Utmost Luxembourg S.A. on the basis of my choice of applicable law or jurisdiction.
