European countries have a diversity of information requirements for unit-linked life insurance companies, so we have developed this document to help you find where a particular item of information can be accessed.

The table overleaf shows you where you can find additional information about your investments in the European Capital Account (Ref E01v2), European Executive Investment Bond (Ref E04v3), European Collective Investment Bond (Ref E05v2), Swedish Executive Portfolio (Ref SEP) and the Executive Life Portfolio (ELP) provided by Utmost PanEurope dac (Utmost PanEurope).

Much general information regarding the operation of our internal funds (such as their valuation and about the units) can be found in the Policy Terms. Specific data about a particular internal fund can be found in our fund factsheets available from our website. You can also find the current prices of our internal funds from our website.

Additional information may be published by the fund provider of the underlying fund. For our internal funds and other collective investment funds available to the Portfolio Bonds (Ref E04v3/E05v2/SEP/ELP), such information is available via Utmost PanEurope although you or your fund adviser may prefer to contact the fund provider directly or visit their website.

We offer you a choice of possible investment solutions or 'building blocks' which you can use to help create your own portfolio with the help of your financial adviser.

The Self Select range of funds are 'mirror funds' that invest into funds provided by external fund providers. Please note their performance will not directly mirror the performance of those underlying funds because of Utmost International's fund charges, taxation adjustments (where relevant) and the Utmost International investment process.

INTERNET ACCESS

At www.utmostinternational.com you can find fund factsheets and the current prices of our internal funds. From there, you can also register for our Online Service Centre, which will give you access to the value of each of your unit holdings, the total value of your policy and the opportunity to switch your fund choices and redirect* future regular premiums.

PORTFOLIO BONDS

If you invest into a Portfolio Bond (Ref E04v3/E05v2/SEP/ELP) policy then some of the assets in the policy may be bank deposits or public company shares.** Such assets will not have the same type of information available as for collective investment schemes and life company internal unit-linked funds. As such it will normally be for you or your fund adviser to access the relevant information yourselves.

- ** Switching and redirecting only available for our European Capital Account (but not currently for residents of Spain).
- ** Public company shares only available for the European Executive Investment Bond (E04v3), the Swedish Executive Portfolio (SEP) and the Executive Life Portfolio (ELP).

Please note that internal funds (including Managed and Sector Solutions and Self Select funds) are not available to Portfolio Bonds that issued after 28 October 2014.
