Known for its security and accessibility, the island offers a stunning natural environment and convenient connections to the UK, Continental Europe and beyond.

With financial stability and a progressive political outlook, the Isle of Man provides a low-tax environment that is open, transparent and aligned with international standards. With a population of almost 85,000, the Isle of Man provides its population with many advantages including an impressive GDP per capita of \$88,328.50.¹ This positions the Isle of Man among the world's top regions for GDP per capita, alongside leading economies such as Switzerland, Ireland, and Luxembourg. For both individuals and businesses, its financially rewarding system, with a straightforward personal income tax structure and no capital gains tax or inheritance tax, together with a globally competitive corporate tax system, for the Island's life assurance businesses, makes the Isle of Man an appealing location for growth and investment.²



The Isle of Man's self-governing status as a British Crown Dependency allows it to maintain complete autonomy over domestic matters, including taxation and regulation, fostering a competitive environment for international finance.

INVESTOR PROTECTION REGIME FOR ISLE OF MAN POLICIES

Utmost International Isle of Man Limited policyholders are covered by the Isle of Man's policyholder protection scheme, The Isle of Man Life Assurance (Compensation of Policyholders) Regulations 1991. If a life company cannot meet its obligations, policyholders will be entitled to claim up to 90% of its liabilities to them as compensation from the scheme.

In addition to the policyholder protection, further protection is also provided through segregation of all policyholder assets from the assets and liabilities of the company and its shareholders in the event of insolvency. The regulatory expectation of Isle of Man long-term life insurance companies is to maintain a Solvency Coverage Ratio (SCR) of at least 125% at all times and at least 150% immediately after the payment of a dividend. Utmost International Isle of Man Limited's SCR is in excess of these requirements.

Utmost International Isle of Man Limited's regulator is the Isle of Man Financial Services Authority (FSA), which is responsible for overseeing the stability of the Isle of Man's financial system and protecting individual investors.

Life insurance companies supervised by the FSA are regulated under rules similar to the Solvency II regime.

Utmost International Isle of Man Limited also complies with all local laws and regulations that apply to linked long-term business and reports to the regulator as required by the FSA Corporate Governance Code of Practice for Insurers.

The Isle of Man Government's credit strength, diverse economy and ability to comply with global tax standards are fundamental to the Isle of Man's Moody's credit rating, which was enhanced to Aa3 Stable in December 2024.⁶ This rating complements Utmost International Isle of Man Limited's Insurer Financial Strength Rating of A+ from Fitch Ratings.
