## PUBLISHED MINIMUM RESIDUAL VALUES AS AT FEBRUARY 2021

HOW MUCH NEEDS TO REMAIN IN A POLICY FOLLOWING AN INDIVIDUAL POLICY SURRENDER OR PART SURRENDER?

#### Applicable to the following Utmost International products:

Collective Investment Bond, Executive Life Portfolio, French Executive Portfolio, Collective Redemption Bond, Executive Redemption Bond\*, European Collective Investment Bond\*, Investment Account, European Executive Investment Bond\*, International Executive Portfolio, Executive Investment Account, Spanish Collective Investment Bond\*, Executive Investment Bond, Swedish Corporate Pension, Executive Investment Pension, Swedish Executive Portfolio\*, Executive Investment Portfolio and Wealth Portfolio.

The minimum residual value that has to remain following an individual policy surrender or part surrender is **the greater of:** 

- $\rightarrow$  £10,000 / US\$15,000 / €15,000 (or currency equivalent), or
- > 15% of the total premiums paid.

If a policy holds assets which are not currently trading, it may not be possible to reduce the policy to the published minimum value.

FOR EXAMPLE	
Total premium paid	£100,000
Policy value	£110,000
Minimum residual value	£15,000 (15% of total premium paid)
Maximum withdrawal	£95,000 (Policy value minus minimum residual value)

#### Applicable to the following Utmost International products:

Executive Investment Plan, Collective Investment Plan, Collective Investment Bond (Hong Kong legacy product only) and Executive Investment Bond (Hong Kong legacy product only)

The minimum residual value that has to remain following an individual policy surrender or part surrender is the greater of:

- > £10,000 / US\$15,000 / €15,000 (or currency equivalent), or
- > 25% of the total premiums paid.

If a policy holds assets which are not currently trading, it may not be possible to reduce the policy to the published minimum value.

FOR EXAMPLE	
Total premium paid	£100,000
Policy value	£110,000
Minimum residual value	£25,000 (25% of total premium paid)
Maximum withdrawal	£85,000 (Policy value minus minimum residual value)

#### Applicable to the following Utmost International products:

European Portfolio Bond, European Wealth Bond, International Wealth Bond and International Portfolio Bond The minimum residual value that has to remain following an individual policy surrender or part surrender is:

#### > £10,000 / US\$15,000 / €15,000 (or currency equivalent).

If a policy holds assets which are not currently trading, it may not be possible to reduce the policy to the published minimum value.

Minimum residual value	£10,000
Maximum withdrawal	£100,000 (Total premium paid)
