It also provides estate planning options to enable your clients to pass on as much of their wealth as possible, for example to their children and grandchildren, by providing a lump sum on death to pay an inheritance tax (IHT) bill.

Payment into the Variable Universal Life (VUL) Plan¹ under the Tailored Life Trust by a settlor is considered a gift for UK IHT purposes and is treated as a chargeable life time transfer (CLT). In addition to this, for providing the death benefit, Utmost International will deduct a charge from the investments held in the VUL Plan. Each charge is also considered a CLT for UK IHT purposes.

The following tables illustrate IHT values for a Tailored Life Trust and how these can accumulate over a seven year period. The values are based on an investment growth rate of 4% before charges and that the life assured is a non-smoker and accepted to be of standard health.
