Utmost Limited is able to accept business from many parts of the world. However, certain countries may have legal, regulatory or taxation rules that may restrict or prevent us from accepting business from customers in those countries.

Utmost Limited has an obligation to conduct its territorial approach in accordance with the requirements of the authorities in the Isle of Man.

The information provided highlights our current guidelines as at 01 June 2018 but is subject to change in the future.

Please read through the information provided and where there is a non-UK element to the application please complete the **Territory Decision Form** included in this document.

TERRITORY GUIDELINES

To help you in this process, Utmost Limited is prepared to consider applications for non-UK residents as detailed below:

- 1 The advice must be given in the UK, Gibraltar, Channel Islands or the Isle of Man. Furthermore, the application form must be signed by the client in the UK, Gibraltar, Channel Islands or the Isle of Man.
- 2 There are countries where buying an Utmost product may contravene sanctions and local regulation. For any case with a non-UK element, the **Territory Decision Form** included in this document must be completed by you and be received and approved by us before any application can be taken further.
- 3 If your client has invested into an Utmost product and later moves outside of the countries specified in point 1, there may be regulatory or legal restrictions preventing additional investments.
- 4 All prospective applications are subject to full Utmost Limited Anti-Money Laundering and Source of Wealth requirements being satisfied. For additional information please contact us.
- 5 We retain the right to review individual cases on their own merits and may, in exceptional circumstances, vary the criteria.

COMPLETING THE FORM

The following Territory Decision Form is designed to be completed by an Utmost sales consultant or a financial adviser. The information will be used to assess if the applicant(s) is/are resident in a country that is acceptable to Utmost Limited.

Please provide as much information as possible. No decision will be made until adequate details have been received.

The most common instances in which Utmost Limited declines applications are as follows:

1. The application has been signed in a country where Utmost Limited is unable to conduct business.
2. The insurance legislation of the particular territory prevents an insurance buyer from placing their insurance business abroad e.g. the legislation states that life insurance needs to be purchased from locally authorised insurers.
3. There are exchange controls in place that prevent the remittance of money from a particular territory onwards to the UK.
4. There are premium tax, local levies or charges issues that could cause complications for Utmost Limited and/or the client.
