## WHAT IS THIS PRODUCT?

### Type

The product is a unit-linked single premium investment bond.

### Objectives

Evolution is an international single premium investment bond with a minimum initial premium of £50,000. Evolution can be linked to a wide range of underlying investment options, including funds linked to stock markets and cash deposits, and the return on the bond depends on the performance of your chosen underlying investments.

### Intended retail investor

You must be aged 18 or over to invest in Evolution, but please note that the type of investor to whom this product is intended to be marketed varies on the basis of the

underlying investment options chosen. Specific information for each of your chosen underlying investments can be found in the fund information documents.

### Insurance benefits and costs

This is a capital redemption bond with no lives assured.

### Term of the product

This is a capital redemption bond which means the bond will continue for 99 years unless surrendered earlier. For each policy segment still in force after 99 years, we will pay the higher of a Guaranteed Maturity Value or the unit value due. If the value in the bond falls below £10,000, Utmost International Isle of Man Limited reserves the right to surrender it.

## WHAT ARE THE RISKS AND WHAT COULD I GET IN RETURN?

### Risk indicator



The risk indicator assumes you keep the product for 10 years. The summary risk indicator is a guide to the level of risk of this product compared to other products. It shows how likely it is that the product will lose money because of movements in the markets or because we are not able to pay you.

We have classified the risk classes of the underlying investment options as ranging from 1 - 7 out of 7, which is the lowest risk class to the highest risk class. This rates the potential losses from future performance as ranging from a very low level to a very high level. The actual level of risk of this product and how your investment could perform will depend on your choice of underlying investment option(s).

**Be aware of currency risk. Payments may be received in a different currency from that of the investment options selected, so the final return will depend on the exchange**

**rate between the two currencies. This risk is not considered in the summary risk indicator shown above.** This product does not include any protection from future market performance. You could lose some or all of your investment. You can surrender your investment at any time without incurring any exit charges. ## WHAT HAPPENS IF UTMOST INTERNATIONAL ISLE OF MAN LIMITED IS UNABLE TO PAY OUT?

Utmost International Isle of Man Limited is covered by the Isle of Man Life Assurance (Compensation of Policyholders) Regulations 1991. If we cannot meet our obligations the policyholders will be entitled to claim up to 90% of our liabilities to them as compensation. The assets to which the value of the bond is linked are held in our name. This means that you do not have any automatic rights to compensation should the underlying fund manager or deposit taker fail. In these circumstances our liability to you will be limited to such amounts, if any, that we can recover from any third party.

## WHAT ARE THE COSTS?

The Reduction in Yield (RIY) shows what impact the total costs you pay will have on the investment return you might get. The total costs take into account one-off, ongoing and incidental costs. The amounts shown here are the cumulative costs of the product itself, for three different holding periods. They include potential early exit penalties. The figures assume you invest £10,000 or currency equivalent. The figures are estimates and may change in the future. The person selling you or advising you about this product may charge you other costs. If so, this person will provide you with information about these costs, and show you the impact that all costs will have on your investment over time. The actual costs depend on your choice of investment option(s). ### **Recommended holding period: 10 years**

This capital redemption bond has a maximum term of 99 years. The bond has no required minimum holding period but is designed as a medium to long term investment. The recommended holding period is 10 years. You can surrender at any time. There may be tax payable when money is taken out, depending on your personal tax circumstances. You currently have 30 days from the day you receive the 'Your Right To Change Your Mind' form to cancel the bond. However, if there has been a fall in value you will not receive back the full amount invested.
