Send the Advance by Embark Data Capture form to Advance by Embark who will set up the client on their platform.

Complete all the required sections of the Utmost International Isle of Man Limited application forms and/or trust forms for your client's chosen Utmost International Isle of Man Limited bond and return to Utmost International Isle of Man Limited at the address overleaf. We will confirm receipt of the application within one working day of arrival.

During the application process:

- › Utmost International Isle of Man Limited will require either an original or original certified copy of your client's passport and address verification to comply with Isle of Man 'know your customer' requirements
- › The adviser linked to the Advance by Embark Platform should be nominated as the Platform Adviser in the nomination section of the application form. The Platform Adviser must sign the form each time a new application is submitted
- › Your client may be asked to provide additional information and/or documentation to meet our regulatory requirements.

The payment of premium must be sent to Utmost International Isle of Man Limited, clearly referencing the client's name and policy number (if available). Any initial charge and/or any cash amount to be retained in the bond's Dealing Account* is deducted from the premium and the remaining balance is then transferred to the Advance by Embark Platform following policy issue and a unique Advance by Embark reference is received by Utmost International Isle of Man Limited. Once the cash has been transferred, Utmost International Isle of Man Limited will provide Advance by Embark with confirmation.

*To cover any ongoing charges or withdrawals due prior to the first Standing Order due date.

- › Advance by Embark will set up the new client on their platform to match the information provided by you using the policy number and name provided by Utmost International Isle of Man Limited to create the client on their platform
- › Once the monies have been received and matched, Advance by Embark will confirm to you that the cash is ready for investment.
