- a. *current custodian<sup>o</sup> and / or bank statement(s) issued to the Customer evidencing that the Customer (either alone or with his/her spouse or children) has a portfolio of not less than HK\$8 million or its equivalent in any foreign currency\*; or*

- b. *certificate issued by an auditor or a certified public accountant evidencing that the Customer (either alone or with his/her spouse or children) has a portfolio of at least HK\$8 million or its equivalent in any foreign currency\*;*

  - iii. a licensed corporation;
  - iv. a person carrying on the business of the provision of investment services and regulated under the law of any place outside Hong Kong, whose business includes acting as a custodian of securities or other property for another person, whether on trust or by contract.
