BEFORE YOU BEGIN

All references to **Utmost** mean Utmost International Isle of Man Limited and Utmost PanEurope dac.

To request a discretionary asset manager to be appointed to your International Wealth Bond, the discretionary asset manager must have Terms of Business with Utmost International Isle of Man Limited and to request a discretionary asset manager to be appointed to your European Wealth Bond, the discretionary asset manager must have Terms of Business with Utmost PanEurope dac. Please check if your requested discretionary asset manager (and any authorised custodian) can be selected for the International Wealth Bond/European Wealth Bond.

I/We understand that Utmost International can accept no responsibility for the effects of any delay or failure to inform them of any such change. I/We also understand that only three changes can be made to the Investment Mandate in any 12 month period.
3. I/We confirm that I/we have also completed the discretionary asset manager's form which contains details of the Investment Mandate.
4. I/We request that Utmost agree for the discretionary asset manager to send reports to me/us which cover the investments that they hold. I/We understand that it will not contain the full value of the International Wealth Bond/European Wealth Bond as this is only provided by Utmost.
5. I/We understand that the discretionary asset manager may use expressions in their Investment Mandate which suggest that they are providing investment management services to me/us because it is easier to understand. I/We understand that no provision in the Investment Mandate will operate so as to cause the International Wealth Bond/European Wealth Bond to be regarded as a Personal Portfolio Bond or for me/us to have a legal or beneficial interest in any of the assets of the International Wealth Bond/European Wealth Bond or for me/us to have a contractual relationship with the discretionary asset manager.
