GENERAL DECLARATIONS WHICH APPLY TO ALL APPLICANTS

1. DATA PRIVACY STATEMENT

I understand that Utmost Services Limited, Utmost International Business Services Limited, Utmost Services Ireland Limited, Utmost Administration Limited, Utmost International Isle of Man Limited, Utmost International Trustee Solutions Limited and / or Utmost PanEurope dac (Utmost International) will process personal information about me and any other party whose personal information I have provided.

The type of personal information processed about me will depend on the purpose for which it has been collected and will include:

- › my contact details
- › information to verify my identity
- › information about my family, lifestyle, health and finances
- › my payment details.

The processing of my personal information may take place in a number of jurisdictions and may be shared with other parties within or outside the Utmost group of companies for the general purpose of establishing, maintaining and servicing an insurance policy. The sharing of my personal data may be used for any or all of the following purposes, to:

- 2.2 I understand that this appointment is revocable and can be changed at any time (as explained in the Policy Terms).
- 2.3 I understand that by agreeing to the appointment of the Lead Policyholder I authorise the Lead Policyholder to provide Utmost International with instructions to carry out and request certain Policy Transactions on behalf of all Policyholders. The instruction or request shall be deemed to have been addressed, sent and authorised on behalf of all Policyholders.
- 2.4 I understand that these instructions will be legally binding and that Utmost International can act on any instruction received from the Lead Policyholder.
- 2.5 Where I am a trustee, I confirm that the provisions of the trust allow delegation of authority to one trustee to act on behalf of all trustees.
- 2.6 Where the application is for a company, I confirm that I have appropriate authority to act on behalf of the corporate entity.

- 3.5 I acknowledge and agree that such confirmation is to enable Utmost International to comply with its regulatory duties as an authorised insurer in the Isle of Man. I understand that this is not, and should not be construed as, any endorsement of the Fund Adviser and that Utmost International does not warrant the fund adviser's suitability or regulatory credentials.

- 3.6 I agree that Utmost International is not responsible for any loss or liability to the policy arising from this appointment.

- 3.7 I confirm that I am aware that if Utmost International becomes aware that a Fund Adviser:
- a. has been refused membership by, or has been expelled from, a professional organisation; or
 - b. is under investigation by or has been subject of disciplinary action by a regulatory authority; or
 - c. has or is carrying out activities in a manner which could prejudice or be harmful to Utmost International's reputation; then

Utmost International reserves the right to cease to act on the instructions of the Fund Adviser, with immediate effect and Utmost International will inform me of the fact.

- 3.8 I understand I must notify Utmost International in writing of any changes which affect this appointment, or the authority of the Fund Adviser. I understand that Utmost International will continue to accept instructions from the Fund Adviser, unless and until I advise Utmost International of a change to this appointment or the authority of the Fund Adviser.

The termination will not affect any transactions already carried out or for which binding instructions have been given directly, or indirectly.
- 3.10 I understand that Utmost International will act exclusively on this authority once granted until I advise Utmost International in writing at its Office of the termination of this appointment.

- 4.4 I request that the Lump Sum referred to as a Premium is invested as I have instructed either as an initial Premium or an additional Premium for Policies comprising an Executive Investment Bond, Executive Redemption Bond, Executive Redemption Bond - PRIIPs, Collective Investment Bond, Collective Redemption Bond, International Executive Portfolio - Life or, International Executive Portfolio - Redemption and I request Utmost International to issue either the policies in my/the trust's/the company's name, jointly with the other applicants, if any.
- 4.5 I declare to the best of my knowledge and belief that the statements made in this application, and any related documents, are true and complete. I have not concealed a material fact. I agree to provide Utmost International with any further information in respect of this application on request.
- 4.6 I confirm that Utmost International has not provided any investment advice and I or my Fund Adviser or the discretionary asset manager is responsible for the selection of assets to be linked to my Portfolio Fund. I acknowledge that Utmost International is not responsible for any loss suffered or reduction in the value of my Policy arising from my investment. Utmost International does not have any responsibility for the management of the underlying assets chosen other than carrying out a treasury function in respect of the Transaction Account and Utmost International does not recommend any asset as a suitable investment.
- 4.7 I confirm that I am not a resident of the United States of America or any of its territories or where the applicant is a company or a trust company, the company or trust company is not incorporated in the United States of America or any of its territories. If I become resident in the United States of America or any of its territories or the company or trust company becomes incorporated in the United States of America or any of its territories, I understand that Utmost International may not be able to accept any further Premiums until after I cease to be a resident in the United States of America or any of its territories or the company or trust company ceases to be incorporated in the United States of America or any of its territories.
- 4.8 I confirm that I/we/the Company have received a copy of the following items and I/we have had the opportunity to read them before reviewing and signing this application: Executive Investment Bond, Executive Redemption Bond, Executive Redemption Bond - PRIIPs, Collective Investment Bond, Collective Redemption Bond, International Executive Portfolio - Life, or International Executive Portfolio - Redemption, Policy Terms and Key Information Document (KID) for the policy and asset Key Information Document(s) (KIDs) and, where appropriate, the asset Key Investor Information Documents (KIIDs) (relevant where the policy is an Executive Redemption Bond - PRIIPs). Furthermore, I/we/the Company agree that where I/we/the Company choose to change assets of the portfolio fund in future, I/we/the Company will ensure that I/we/the Company will obtain asset Key Information Document(s) for those assets before they are purchased.

- 4.9 I am aware of the charges payable on the Policy, including the charges payable in respect of the investments which may be held within it. I understand the charges exist partly to meet advice, promotion and distribution expenses. These may include initial and ongoing payments (such as commission) made to my financial adviser. These payments could be in addition to any commission payable by the investment provider to the financial adviser in respect of the investments held. I understand that Utmost International may receive payments in the form of fund manager rebates from an investment provider in respect of the investments held, and which Utmost International may share with my financial adviser.

- 5.3 I understand that the Policy allows investment into various types of Assets and some of these Assets are only suitable for Professional Investors. I accept the level of risk associated with these Assets including the risk that the investment into such an Asset:
- a. could provide a lesser degree of investor protection and regulatory safeguards; and
