# STOCKBROKER CHARGES

Where a cash value is provided, the trading value will be based on the previous day's closing price and will therefore be subject to market movements. This could result in an investment or sale instruction that does not reflect the exact value of the trade that was intended.

#### SAFE CUSTODY CHARGES

Safe Custody Charges may apply where a trade is placed in exchange traded assets (such as bonds, ETFs, Equities and Investment Trusts.)

## > Transaction settlement charge

The transactional settlement charge occurs each time there is a dealing transaction. It will be a fixed monetary charge defined in GBP and taken in the currency of the asset, using the applicable exchange rate at the time of the transaction. For a transaction involving buying one asset and selling another, the charge will be incurred twice.

# > Administration safe custody charge

The administration safe custody charge will be a percentage of the asset value held, taken each quarter in the bond/policy/plan/account currency, where the percentage charge will vary based on the asset currency/market.

On full encashment, any outstanding safe custody charges will be deducted from the encashment value. This will include all the transaction settlement charges incurred and pro-rata administration safe custody charges. The level of these charges are:
