Based on the EU Directive on Administrative Cooperation in Tax Matters (the “**DAC**”) and the OECD Common Reporting Standard (the “**CRS**”), Utmost Luxembourg S.A. - Italian Branch is required to collect and report certain information about an Account Holder’s* tax residency status.

Please note that all capitalised terms shall have the meaning ascribed to them under DAC and CRS.

* The term "Account Holder" means the Policyholders or any other persons who have access to the cash value or who can change the beneficiary of the Policy.
