ABOUT THIS FUND LIST

This fund list details the Guided Architecture funds available through Evolution and the Estate Planning Bond.

Guided Architecture is comprised of the Utmost Fund Collection and the Tailored Selection range. The Utmost Fund Collection consists of money funds managed by Utmost Limited and the Utmost Deferred Distribution Fund which is a mirror fund. The Tailored Selection range are all mirror funds. Tailored Selection is grouped into three categories:

- › **Active funds** - Funds aiming to outperform the benchmark with an active investment strategy
- › **Extended Selection** - A slightly wider range of funds to allow more choice
- › **Showcase range** - Innovative or unique funds offering good diversification.

MIRROR FUNDS

The objective of mirror funds is to mirror as closely as possible the performance of the underlying fund. However, in some instances, performance may not match the underlying fund, and certain factors may reduce the potential for growth. The key reasons for this include:

- › The mirror fund may not be wholly invested in the underlying fund, as it can hold a cash position
- › There are timing differences and additional administration costs of running the mirror fund.



Mirror funds may be withdrawn without notice, e.g. if the underlying fund is withdrawn or suspended.

DEALING CHARGES

Currently purchases and sales of the Utmost Fund Collection and Tailored Selection funds do not incur a dealing charge. However, the unit prices of some of our funds are determined by the prices at which the underlying funds can be bought or sold. Furthermore, underlying assets typically have a higher price when being bought and consequently the fund transaction price can alter purely as a result of sales or purchases of the assets of the fund. Such changes will affect the value of your investment, and are in addition to any initial fund charge illustrated. For further information on such charges, please speak to your financial adviser.

FUND CHARGES

The Ongoing Charges Figure (OCF) quoted against each fund consists of the Annual Management Charge (AMC) and fund expenses of the fund (and any underlying fund). The OCF is accrued on a daily basis and is reflected in the fund's price.

- › The AMC includes costs associated with the administration and operation of the fund, such as fund manager costs, investment adviser fees, custodian and depositary fees, regulator fees, audit fees, and the valuation of underlying assets
- › Fund expenses include any underlying asset trading costs and broker fees. As transactional activity varies, this element of the OCF can fluctuate and therefore the actual OCF applied may be slightly different to that quoted.
